CALL FOR VISITING PROFESSORS FROM RESEARCH INSTITUTIONS OUTSIDE ITALY 2nd TERM 2025-2026 and 1st TERM 2026-2027 ACTIVITY DEADLINE: 31st December 2026

Deadline for submission of applications: 7th March 2026

**(REGIONAL LAW No 2/2011 – FUNDS 2026
and university's funds)**

Article 1 – Recipients and purposes of the scheme

The University of Trieste shall select and support full and associate professors from foreign institutions (or individuals with equivalent positions in foreign research institutions) through the Visiting Professorship Scheme. During a visiting professorship, the recipient will deliver lectures within the university's bachelor's, master's, specialisation and doctoral degree courses.

This call is addressed to the Departments of the University of Trieste interested in inviting scholars with a view to expanding the range of educational activities within the department and developing the University's international profile.

Under no circumstances will the Visiting Professor be in charge of a whole course.

Article 2 – Duration

- a. Visiting professorships may be taken up during the second term of academic year 2025-2026 and the first term of academic year 2026-2027.
Activities may start from **8th April 2026** and must be completed by **31st December 2026** without exception.
- b. Specialisation courses in medical fields:
Professorships held within these specialisation courses will have to be carried out in the second term of academic year 2024-2025 or in the first term of academic year 2025-2026.
- c. Minimum duration of a professorship:
A visiting professorship must last **no less than 10 continuous working days**.

During their visiting period, professors are required to carry out their teaching activities in compliance with the regulations of the University of Trieste.

Article 3 –Professorships and value

A maximum of sixteen (16) visiting professorships will be funded.
The following professorships will be activated:

- 12 professorships under the Regional Law No 2/2011 – Funds 2026
- 4 professorships under University's funds

Each Department will be guaranteed at least one Visiting Professor position, provided that the applications are positively evaluated.

In identifying candidates, the Departments must safeguard the principle of gender balance.

For each Visiting Professorship the selected Department will receive **EUR 3.571,43**, corresponding to the Visiting Professor's overall amount (**EUR 2.500,00 net**).

Departments shall not be granted any further reimbursement.

The amount will be paid in a single instalment to the host Department, which will pay the Visiting Professor upon completion of the assigned activity, after s/he has submitted her/his final report on the activity carried out.

If a Visiting Professor has their tax residence in a country which has with Italy a convention aimed at avoiding double taxation, s/he may submit a request before her/his wages are paid. S/he must do so by filling in the required form(s), in accordance with the provisions of the relevant convention and submit all documentation to the host Department.

The relevant form is available on the website of the [Italian Revenue Agency](#) (*Agenzia delle Entrate*).

A visiting professorship does not give the holder the right to enrolment as teaching staff at the University of Trieste.

Article 4 – Visiting Professor's commitment

The Visiting Professor is required to carry out the following activities in English or in another foreign language consistent with the course in which the activity will be held:

1. **4 hours** of lectures within one or more courses of type A or B or C (core subjects, advanced concepts and skills or complementary subjects) as part of a bachelor's, master's or doctoral degree.

Visiting professorships held within specialisation courses in medical fields must be carried out in the second term of academic year 2024-2025 or in the first term of academic year 2025-2026.

Lectures may be given across different courses, provided they:

- meet the above requirements
- are offered by the host department
- are given by the same Visiting Professor.

2. **a seminar held at the host department;**
3. **a roundtable addressed to PhD students** enrolled at the University of Trieste. The organisation of the roundtable must be agreed upon by the Visiting Professor and the coordinator(s) of the PhD school(s) involved. In the case of joint doctorates, the workshop will be held at the University of Trieste.

Departments that do not offer a PhD course will have to organise an interdisciplinary roundtable addressed to all PhD students at the University.

Activities within courses for bachelor's and master's degrees (lectures) must be scheduled within the academic calendar and must comply with the relevant University regulations and especially with the *Guidelines on course offering and scheduled educational activities* approved by the Academic Senate on 16th July 2024. In the case of a visiting professorship, however, lectures must be taught in person.

Article 5 – Insurance

The insurance coverage provided for by current regulations, as well as the existence of insurance coverage related to the specific activities to be carried out (e.g., access to laboratories, use of equipment, etc.), must be verified by the host Department, before the arrival of the Visiting Professor, with the University Office responsible for insurance matters.

If the Visiting Professor comes from a Member State of the European Union, being in possession of the EHIC (European Health Insurance Card), they are entitled to healthcare coverage.

Article 6 – Application process

Applications must be submitted by the relevant department.

Each department may submit no more than **three** applications, indicating an order of priority.

Applications must be submitted by university departments using the form attached to this call (**Annex A**). The form must be signed by the Head of Department.

This form and the documents listed in this paragraph, must be sent to relazioni.internazionali@amm.units.it by **7th March 2026**.

The subject of the email must be the following: **BANDO DI ATENEIO - SELEZIONE PER 16 POSIZIONI DI VISITING PROFESSOR - ANNO 2026 – FONDI REGIONALI E FONDI UNITS.**

Pursuant to Article 18(1)(b) and (c) of Italian Law No 240/2010 and subsequent amendments and additions, candidates are not eligible if, at the deadline for applications, they have up to a fourth degree of kinship by consanguinity or affinity with: a member of teaching staff within the host department, the Rector, the General Director or a member of the Board of Directors of the University of Trieste.

Applications are welcome from candidates who were approved by the University International Committee but were not selected in the *University Call (pending the allocation of the 2026 budget financed under the Ministerial Three-year Programme 2024–2026) – Selection of Visiting Professors from foreign universities or research institutions – Academic Year 2025/2026, second semester, and*

Academic Year 2026/2027, first semester – activities to be completed by 31 December 2026 – year 2026 – application deadline: 13 June 2025 – candidates were evaluated and awarded.

Along with Annex A, the department must submit:

1. a **copy of the minutes** of the department council meeting in which the department committed to hosting the Visiting Professor. The minutes of the meeting must also clearly indicate if the department prioritises one candidate over the other. The council should have met before the deadline for the submission of applications indicated in this call. However, if the scheduled meetings do not allow it, applications can also be submitted by decree signed by the head of department. In this case, the decree will have to be approved by the relevant department council at the first appropriate meeting. The department will send a copy of the minutes of the meeting to the relevant office.

If the minutes of the meeting are not available at the time of submission, the department may send a copy of them to relazioni.internazionali@amm.units.it within seven days of the application deadline.

The minutes of the meeting must indicate:

- a) the candidate's details and university or institution of origin, the academic discipline of the taught course and a short description of the candidate's academic standing and international achievements;
 - b) the reason for the proposal;
 - c) description of the activity the candidate will carry out (number of hours, type of activity and period in which it will be carried out);
 - d) period of stay of the Visiting Professor;
 - e) contact within the department;
 - f) mobility period and activities carried out during any previous visiting professorship at the University of Trieste;
 - g) commitment of the host department to ensure:
 - provision of a workstation within the host structure;
 - the availability of the equipment necessary to carry out the planned activities;
 - h) verification of the necessary insurance aspects;
2. curriculum vitae of the Visiting Professor drawn up in English;
 3. a declaration of interest drawn up in English and signed by the candidate using the form in Annex B of this call;
 4. copy of a valid identity document of the Visiting Professor.

Article 7 – Selection

The Unit for Development Cooperation and University Networks will verify that each application complies with the admission requirements set in this call.

Eligible applications will then be forwarded to the University International Committee, appointed by Resolution of the Board of Directors No. 510/2025 – Protocol No. 192281/2025.

The Committee will evaluate all applications on the basis of the following criteria:

- a) reason for the proposal;
- b) curriculum vitae and international standing of the candidate;
- c) international standing of the candidate's university or research institution of origin;
- d) relevance of the activity that the candidate is invited to carry out.,
- e) duration of the activity carried out at the University of Trieste;
- f) impact on the University's internationalisation scheme.

The ranking of selected candidates will be submitted to the academic bodies of the University of Trieste for their approval.

The University's Unit for Development Cooperation and Networks will publish the results of the selection on the dedicated pages of the University website.

Art. 8 – Further documents

a) Templates

In order to ensure uniformity across all the documentation to be used within the framework of this Call, the University has prepared the following templates, which form an integral part of this Call and must be used by the Departments: invitation letter, letter of acceptance, expense report, final report.

b) Affiliation Agreement

As provided for by Article 4, paragraph 3 of the Regulation of the University of Trieste on Visiting Scientists, upon the arrival of the Visiting Professor the Department shall prepare an Affiliation Agreement, setting out the commitments of the parties. The document shall be signed by the Visiting Professor and by the Head of the Department. A signed copy of this document shall subsequently be forwarded to the competent University office for Visiting Scientists.

c) Final report

At the end of the visiting period, the Visiting Professor shall submit to the Department a report on the activities carried out. The report shall be countersigned and integrated by the academic contact person and shall highlight the contribution made by the visit to the University's internationalisation process. A copy of the final report shall also be sent to the Unit for Development Cooperation and University Networks by **31 December 2026**.

d) Final certificate

The University shall issue the Visiting Professor with a certificate attesting to their stay at the University and the contribution their presence has made to the University's internationalisation process.

Article 9 – Advertising and conclusion of proceedings
